

Invitation to Apply for Eligibility and to Bid
Republic of the Philippines

RENOVATION OF NAGA CITY HOSPITAL & CONSTRUCTION OF 2-CL SCHOOL BUILDING

The *City Government of Naga*, through the *Trust Fund-Priority Development Assistance Fund (PDAF) and Special Education Fund (SEF)*, intends to apply the following (see table below), being the Approved Budget for Contract (ABCs) to payment under the contract for *the Proposed Renovation of Naga City Hospital & Construction of 2-CL School Building*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *City Government of Naga* now calls for the submission of Letters of Intent (LOIs) from potential bidders to apply for eligibility for the *Proposed Renovation of Naga City Hospital & Construction of 2-CL School Building*. Bidders should possess a valid PCAB license applicable to the above type and cost of the contract, have completed a similar contract with a value of at least fifty percent (50%) of the ABC, and meet the other minimum eligibility requirements stated in the Eligibility Documents. Interested Bidders must submit their LOIs on starting on **Friday, May 23 to 29, 2008, from 8:00 AM to 5:00 PM at the BAC Chairman c/o BAC Secretariat, City Planning and Development Office (CPDO)** and secure the Eligibility Documents therefrom upon payment of a nonrefundable fee of **Five Hundred (Php 500.00) Pesos**. Applications for eligibility will be evaluated on a "pass/fail" basis. The submission of the accomplished Eligibility Documents, in three (3) copies, original, copy 1 and copy 2, shall be on or before **Friday, May 30, 2008, 8:00 AM to 3:00 PM at the BAC Secretariat, City Planning and Development Office (CPDO)**. Eligibility check will be conducted on the same day, 3:00 PM at **Vice Mayor's Office**. Only those Bidders passing the eligibility check will be entitled to purchase the Bidding Documents.

Bidding will be conducted through open competitive bidding procedures as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act," and is restricted, unless otherwise stated, to organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines. In accordance with the IRR-A of R.A. 9184, only Bids from eligible Bidders will be opened. In accordance with the IRR-A of R.A. 9184 a contract will only be awarded to the Lowest Calculated and Responsive Bidder who was determined as such during post-qualification.

A complete set of Bidding Documents may be purchased by Bidders that passed the eligibility check upon the presentation of the Notice of Eligibility to the BAC Secretariat, at the *City Planning and Development Office* and upon payment of a nonrefundable fee (please see table above). The Bidding Documents shall be received personally by the bidder or his authorized representative from **8:00 AM to 5:00 PM on June 3, 2008**.

The City Government of Naga will hold a Pre-Bid Conference open to all Eligible Bidders on Friday, June 6, 2008, 3:00 PM at the Vice Mayor's Office.

Eligible Bidders must submit their Bids at the **BAC Chairman, c/o BAC Secretariat, City Planning and Development Office, 2nd Floor City Hall Main Building, City Hall Compound, Naga City** on or before **3:00 PM on Friday, June 20, 2008**. All Bids must be accompanied by a Bid security in the form of **cash; cashier's or certified check; irrevocable letter of credit; bank guarantee; and, surety bond**, in Philippine Pesos. Late Bids shall not be accepted. Bid opening shall be on **Friday, June 20, 2008 at 3:00 PM at the Vice Mayor's Office**. Bids will be opened in the presence of the Bidder or their representatives who choose to attend.

The *City Government of Naga* reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
