SUPPLY & DELIVERY OF MEDICAL MATERIALS

The *City Government of Naga*, through the *City Health Office's 2009 Budget for Medical, Dental & Laboratory Supplies*, intends to apply the sum of **ONE HUNDRED ELEVEN THOUSAND TWO HUNDRED ONE & 95/100 (Php 111,201.95) Pesos**, being the Approved Budget for the Contract (ABC) to payment under the contract for the *Supply & Delivery of Medical Materials for use in the OPD consultation and barangay health stations of the city's 27 barangays, Project Reference Number: 2009-024*. Bids received in excess of the ABC shall be automatically rejected at Bid opening.

The *City Government of Naga* now invites Bids from eligible Bidders for the ***Supply & Delivery of Medical Materials***. Delivery of the GOODS is required within thirty (30) calendar days *after receipt of Notice to Proceed*. The description of an eligible Bidder is contained in Section I of the Bidding Documents, Instructions to Bidders (ITB).

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act," and is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138). Only Bids from Bidders who pass the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents, ITB. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who will be determined as such during the post-qualification procedure.

Interested Bidders may obtain further information from *City Government of Naga* and inspect the Bidding Documents at the address given below ***starting today, July 2 to 23, 2009 from 8:00 AM to 5:00 PM.***

A complete set of Bidding Documents may be purchased by interested bidders from the address below and upon payment of a nonrefundable fee in the amount of ***One Thousand Five Hundred (Php 1,500.00) Pesos.*** The method of payment will be in CASH. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.

The *City Government of Naga* will hold a Pre-Bid Conference open to all interested parties on ***Friday, July 10, 2009 at 3:00 PM at the Vice Mayor's Conference Room.***

Bids and eligibility requirements, **in three (3) copies, original, copy 1 & 2,** must be delivered to the BAC Chairman, c/o BAC Secretariat, City Planning & Development Office, **on or before 3:00 PM on Friday, July 24, 2009.** All Bids must be accompanied by a Bid security in the form of the following: **Cash, certified check, cashier's check, bank draft or irrevocable letter of credit; or, Bank Guarantee or, Surety Bond,** in Philippine Pesos. Late Bids shall not be accepted.

Bid opening shall be on ***Friday, July 24, 2009 at 3:00 PM at the Vice Mayors Conference Room.*** Bids will be opened in the presence of the Bidders or representatives who choose to attend.

The *City Government of Naga* reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
