**RESOLUTION NO. 2002-155**

**RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) TO ACCREDIT THE METRO NAGA PUBLIC EMPLOYMENT SERVICE OFFICE (METRO PESO) IN THE CITY GOVERNMENT OF NAGA AS A RECRUITMENT ENTITY: -**

**WHEREAS**, on July 5, 1988, THE City Government of Naga and the Naga City Chamber of Commerce and Industry signed a Memorandum of Agreement which would become, so to speak, the seed for the eventual establishment of one of the first Community Employment Centers (CECs) in the Country;

**WHEREAS**, on May 20, 1998, the Sangguniang Panlungsod enacted Ordinance No. 98-071, institutionalizing the Metro Naga Public Employment Service Office (Metro PESO);

**WHEREAS**, the Metro PESO has established collaborative partnership with government organizations, non-government/people's organizations, the private sector and the communities whereby it acts as the primary facilitator benefiting its clientele as well as the community;

**WHEREAS**, for employment facilitation, the Metro PESO focuses on the different programs of the DOLE, DILG and DPWH including the Special Program for the Employment of Students (SPES), Work Apprentice Program (WAP), Working Youth Program (WYP), TULAY 2000, Apprenticeship and Learnership Program (ALP), Government Internship Program (GIP), Youth in Infrastructure Development Program (YIDP) and Local and Overseas Employment Assistance, which resulted in the facilitation of at least 1,500 new jobs a year;

**WHEREAS**, the favorable consideration of the Department of Labor and Employment (DOLE) of accrediting the Metro PESO as a recruitment entity would greatly contribute to its aim of providing more opportunities for livelihood and employment;

**NOW THEREFORE**, on joint and collective motion of the Members of the 7<sup>th</sup> Sangguniang Panlungsod of the City of Naga;

**BE IT RESOLVED**, as it is hereby resolved, to earnestly request the Department of Labor and Employment (DOLE) to accredit the Metro Naga Public Employment Service Office (Metro PESO) in the City Government of Naga as a recruitment entity.

**LET COPIES** of this resolution be furnished His Honor, the City Mayor for his concurrence and the Department of Labor and Employment (DOLE) thru the Honorable Secretary Patricia A. Sto. Tomas, for their favorable consideration.
