RESOLUTION REQUESTING THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) THROUGH SECRETARY PATRICIA STO. TOMAS TO FACILITATE THE RELEASE OF THE FUND FOR THE DOLE COUNTERPART IN THE 2001 SPECIAL PROGRAM FOR THE EMPLOYMENT OF STUDENTS (SPES) IN NAGA CITY: -

WHEREAS, received by the Sangguniang Panlungsod was the letter dated July 10, 2002 from Jeffrey M. Diezmo, a student and beneficiary of the Special Program for the Employment of Students (SPES), informing of their non-receipt of the 40% pay for their services as SPES beneficiary for the year 2001 representing the Department of Labor and Employment (DOLE) counterpart in the said program;

WHEREAS, SPES is a program of the Department of Labor and Employment in partnership with the local government units and private entities who pay 60% of special wage rates with DOLE subsidizing the remaining 40%;

WHEREAS, this program nobly aims to assist students of low income families to generate funds for their school fees needs while at the same time training them for certain possible future employment;

WHEREAS, in the City of Naga alone, there were over one thousand qualified students who availed of the program for the year 2001;

WHEREAS, out of this number, 589 beneficiaries remain unpaid and wanting to receive the 40% counterpart from the Department of Labor and Employment;

WHEREAS, the delay in the release of the fund for this purpose is defeating the purpose of the program;

NOW, THEREFORE, on motion of Hon. Gabriel H. Bordado, Jr., seconded by Hon. Mila Raquid-Arroyo and Hon. Lourdes V. Asence, M.D.;

BE IT RESOLVED, as it is hereby resolved, to request the Department of Labor and Employment (DOLE) through Secretary Patricia Santo Tomas to facilitate the release of the fund for the DOLE counterpart in the 2001 Special Program for the Employment of Students (SPES) in Naga City.

LET COPIES of this resolution be furnished His Honor, the Acting City Mayor for his concurrence, the Department of Labor and Employment (DOLE) through Secretary Patricia St. Tomas for their appropriate action, the Metro Naga Public Employment Service Office (Metro PESO) and the DOLE Regional Office, for their information and guidance.
