RESOLUTION CREATING THE NAGA CITY INTER-AGENCY COMMITTEE ON EMPLOYMENT PROMOTION, PROTECTION AND REHABILITATION OF PERSONS WITH DISABILITIES, DEFINING ITS COMPOSITION, DUTIES, FUNCTIONS AND RESPONSIBILITIES: -

WHEREAS, on 17 July 1995, His Excellency President Fidel V. Ramos signed into law Executive Order No. 261 creating an Inter-Agency Committee on Employment Promotion, Protection and Rehabilitation of Persons with Disabilities;

WHEREAS, the creation of this Committee is important to enhance the meaning and substance of the Magna Carta for Disabled Persons and other relevant laws on employment;

NOW, THEREFORE, on motion of Hon. Jose C. Rañola, M.D. seconded by Hon. Jose A. Tuason, Hon. Jaime S. Jacob, Hon. Gabriel H. Bordado and Hon. Jorge S. de Guzman;

BE IT RESOLVED, as it is hereby resolved, to create the Naga City Inter-Agency Committee on Employment Promotion, Protection and Rehabilitation of Persons with Disabilities under the following composition, duties, functions and responsibilities:

FUNCTIONS:

1. To coordinate and monitor the implementation of and compliance with the employment provisions of the Magna Carta for Disabled Persons, and other relevant laws.
2. To develop, coordinate and implement a continuing program of public information and education designed to provide increased employment opportunities for persons with disabilities;
3. To foster, strengthen and ensure cooperation among all government agencies, private organizations and individuals, in collaboration with the International Labor Organization, in the enhancement of employment of persons with disabilities by promoting the alignment of their policies and programs with the Magna Carta for Disabled Persons and other relevant laws;
4. To identify, formulate and advocate legislative and administrative measures and policies designed to promote, protect and uplift the welfare and employment of persons with disabilities; and
5. To promote and assist in the conduct of relevant studies and researches on vocational rehabilitation; occupational safety and health, and in the conduct of awareness-raising and advocacy, particularly those pertaining to equalization of opportunities and participation of persons with disabilities in their development.
