## **RESOLUTION NO. 99-384**

### **RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY GOVERNMENT OF NAGA, TESDA, DTI, DOLE, MNCCI, MIAP-CAM. SUR, NCUPFI, ABS AND BASRAMP RELATIVE TO THE IMPLEMENTATION OF THE NAGA CITY INTEGRATED LIVELIHOOD DEVELOPMENT PROJECT: -**

**WHEREAS**, the City of Naga, the TESDA, DTI, DOLE, MNCCI, MIAP-Cam. Sur, NCUPFI, ABS and BASRAMP have entered into a Memorandum of Agreement on April 14, 1999 relative to the implementation of the Naga City Integrated Livelihood Development Project;

**WHEREAS**, the Naga City LGU is determined to pursue an Integrated Livelihood Development Program with the assistance of key government agencies and the private sector;

**WHEREAS**, pilot implementation of the said program has been proposed by the agencies/offices involved covering seven (7) projects which are the most viable in terms of raw materials and human resources;

**WHEREAS**, the implementation of the Naga City Integrated Livelihood Development Project requires the support of all agencies/offices involved in its conceptualization, as well as other agencies/officer whose functions can provide support to project beneficiaries;

**WHEREAS**, the key government agencies and the private sectors have agreed and bind themselves to provide technical assistance to the implementation and monitoring bodies of the LGU;

**WHEREAS**, finding the Memorandum of Agreement to be in order and beneficial to the city; and it being in line with the national policy of enhancing linkages with local government units and the private sectors;

**NOW, THEREFORE**, on motion of Hon. Fiel L. Rosales seconded by Hon. Mila S.D. Raquid-Arroyo;

**BE IT RESOLVED**, as it is hereby resolved, to approve the Memorandum of Agreement entered into by and between the City of Naga, TESDA, DTI, DOLE, MNCCI, MIAP-Cam. Sur, NCUPFI, ABS and BASRAMP relative to the implementation of the Naga City Integrated Livelihood Development Project.
