CREATING THE NAGA CITY PALARONG BICOL TASK FORCE, DEFINING ITS COMPOSITION AND FUNCTIONS

WHEREAS, Naga City will be this year's host to the Palarong Bicol;

WHEREAS, there is a need to prepare billeting centers and playing venues and to ensure that support services are adequately delivered on time;

WHEREAS, assignments have been given during a joint meeting with the DepEd and preparatory activities are already on-going;

WHEREAS, there is now a need to structure these assignments to better streamline the line of responsibility and command;

NOW THEREFORE, by virtue of the powers vested in me by law, I, JESSE M. ROBREDO, do hereby create the Naga City Palarong Bicol Task Force with the following composition and functions:
